The amount of the inspection fee due is determined by the number of units of dwelling space in any building or project. Please notify the Bureau of Housing Inspection in writing if information on the application does not agree with your records.

Another Application for Certificate of Inspection and inspection fee will not be required for at least 5 years after the date of inspection noted above.

In the event that the application is not filed and the required fee is not paid by the due date indicated, you will be subject to a penalty for failure to comply with this order, pursuant to N.J.S.A. 55:13A-19.
