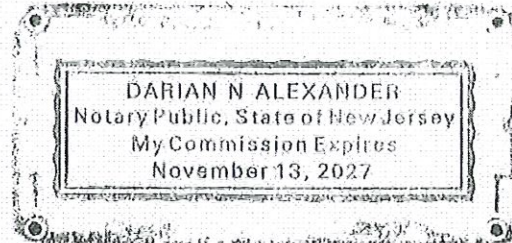

PLEASE TAKE NOTICE that LOVELY HOMES, LLC (the "Applicant") has filed an application bearing Application Number Z-23-016 with the Zoning Board of Adjustment of the City of Bayonne regarding the real property located at 78 West 52nd Street, Block 44, Lot 35.01 on the Tax Map of the City of Bayonne (the "Property"). The aforementioned application seeks the following relief:

The site is currently a vacant 25 X 100 lot. Applicant seeks to construct a new 2-family house on this lot with 3 off-street parking spaces. Variances will be sought for minimum lot width and area, and for number of stories. The proposed height of the structure is conforming, however due to the Bayonne ordinances' technical definition of a full story, the ground floor as well as the cellar each count as a full story. Therefore the applicant is technically proposing to construct a 4-story house on the site (including the cellar as a story), however only 3 stories will be above ground and the height will still be at or under 35' - as such no variance is required for height. Applicant also seeks a rear yard setback variance of 3' due to a proposed 3' balcony in the rear yard. Any additional approvals, permits, variances, interpretations, waivers or exceptions reflected in the plans and materials filed (as same may be amended or revised from time to time without further notice) or determined to be necessary during the review and processing or hearing of this application will also be sought.

A public hearing for this application is scheduled for September 16, 2024 at 6:00 pm at Dorothy E. Harrington Municipal Court Chambers, 630 Avenue C, Bayonne, NJ before the Zoning Board of Adjustment. Any interested party may appear at said hearing and participate therein in accordance with the rules of the Zoning Board of Adjustment.
