PLEASE TAKE NOTICE that a public hearing of the Planning Board has been scheduled for Tuesday, July 14, 2026 at 6:00 p.m. in the Dorothy E. Harrington Municipal Council Chambers, 630 Avenue C, Bayonne, NJ 07002 to hear an amended application filed by ZARA REALTY, LLC, bearing application no. P-26-004 with the City of Bayonne Planning Board for property located at 7 West 9th Street in City Block 283, Lot 23.01 on the City Tax Map. The applicant was previously approved for major site plan and bulk variance relief to allow the construction of three additional stories to the existing building creating four new residential dwelling units.
