**AN ORDINANCE AMENDING AND SUPPLEMENTING THE REVISED  
GENERAL ORDINANCES OF THE CITY OF BAYONNE, CHAPTER 7,  
TRAFFIC**

**BE IT ORDAINED**, by the Municipal Council of the City of Bayonne, as follows:

**Section 1.** That the Revised General Ordinances of the City of Bayonne Chapter 7, Traffic, Section 7-37.3, Handicapped Parking on Street for Private Residences, be and is hereby amended and supplemented as follows:

**RESTRICTIVE PARKING ZONES**  
**DELETE**

**018. Donna Burgess, 126 West 23<sup>rd</sup> Street**

South Side. Beginning at a point 245 feet east of the southwest corner of Avenue A and West 23<sup>rd</sup> Street and extending to a point 16 feet thereof.

**033. Joanne Strifolino, 25 East 44<sup>th</sup> Street**

North Side. Beginning at a point 320 feet east of the northeast corner of Broadway and East 44<sup>th</sup> Street and extending to a point 16 feet east thereof.

**051. Kathleen Kelder, 91 Newman Avenue**

West Side. Beginning at a point 140 feet south of the southwest corner of Newman Avenue and West 4<sup>th</sup> Street and extending to a point 17 feet south thereof.

**054. Sussanne Gerald, 87 West 19<sup>th</sup> Street**

North Side. Beginning at a point 243 feet of the northeast corner of Kennedy Blvd. and West 19<sup>th</sup> Street and extending to a point 16 feet east thereof.

**146. Pasquale Daddi, 25 East 27<sup>th</sup> Street**

East 27<sup>th</sup> Street Northside. Beginning at a point 316 feet east of the northeast corner of Broadway and East 27<sup>th</sup> Street and extending to a point 22 feet east thereof.

**214. Francis Serafin, 70 West 32<sup>nd</sup> Street**

West 32<sup>nd</sup> Street South Side. Beginning at a point 157 feet west of the southwest corner of Avenue C and extending to a point 22 feet west thereof.

**073. Patrick Boyle, 103 West 6<sup>th</sup> Street**

North Side. Beginning at a point 88 feet east of the northeast corner of Humphrey Avenue and West 6<sup>th</sup> Street and extending to a point 16 feet east thereof.

**RELOCATE**

**011. Hilda Velasco from 65 West 19<sup>th</sup> Street to 59 Cottage Street**

**Old location:** North Side, beginning at a point 153 feet west of the northwest corner of Avenue C and West 19<sup>th</sup> Street and extending 16 feet west thereof.

**New Location:** North side, beginning at a point 246 feet west of the northwest corner of Hobart Avenue and Cottage Street and extending to a point 16 feet west thereof.
