**AN ORDINANCE AMENDING AND SUPPLEMENTING THE GENERAL ORDINANCES OF THE CITY OF BAYONNE, CHAPTER 7, TRAFFIC, SECTION 7-15, PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS, AND SECTION 7-24, STOP INTERSECTIONS.**

**BE IT ORDAINED, by the Municipal Council of the City of Bayonne, as follows:**

**SECTION 1:** That the Revised General Ordinances of the City of Bayonne, Chapter 7, Traffic, Section 7-15, Parking Prohibited At All Times On Certain Streets, be and is hereby amended and supplemented to include the following sites (additions **\*\*between asterisks and/or in bold\*\***, deletions {within brackets and/or ~~struck through~~):

Names of Streets	Sides	Location
<b>**Goldsborough Drive</b>	<b>both sides</b>	<b>between Route 440 and 200 feet east of Cross Lane**</b>
<b>**Chosin Few Way</b>	<b>both sides</b>	<b>between Goldsborough Drive and East 40<sup>th</sup> Street**</b>
<b>**Cross Lane</b>	<b>both sides</b>	<b>between south curbline of Goldsborough Drive to a Point 200 feet south**</b>

**SECTION 2:** That the Revised General Ordinances of the City of Bayonne, Chapter 7, Traffic, Section 7-24, Stop Intersections, be and is hereby amended and supplemented to include the following sites (additions **\*\*between asterisks and/or in bold\*\***, deletions {within brackets and/or ~~struck through~~):

<b>**Goldsborough Drive and Chosin Few Way</b>	<b>On NW Corner WB**</b>
<b>**Goldsborough Drive and Chosin Few Way</b>	<b>On NW Corner SB**</b>
<b>**Goldsborough Drive and Chosin Few Way</b>	<b>On Southside Driveway NB**</b>
<b>**Goldsborough Drive and Cross Lane</b>	<b>On SE Cornet NB**</b>
<b>**Goldsborough Drive and Costco Driveway</b>	<b>Southbound Exit**</b>
<b>**Goldsborough Drive and CVS Driveway</b>	<b>Northbound Exit**</b>
<b>**Chosin Few Way and Costco Driveway</b>	<b>on Southwest Corner**</b>
<b>**Chosin Few Way and Costco Driveway</b>	<b>on Northwest Corner SB**</b>

**SECTION 3. BE IT FURTHER ORDAINED** that all ordinances or parts of ordinances in conflict or inconsistent with this ordinance are hereby repealed, but only, however to the extent of such conflict or inconsistency, it being the legislative intent that all other ordinances or parts of ordinances now existing and in effect, unless the same be in conflict or inconsistent with any of the provisions of this ordinance, shall remain in full force and effect; and

**SECTION 4. BE IT FURTHER ORDAINED** this amending ordinance shall become effective upon due passage and publication according to law.
