**AN ORDINANCE AMENDING AND SUPPLEMENTING THE REVISED  
GENERAL ORDINANCES OF THE CITY OF BAYONNE, CHAPTER 7,  
TRAFFIC**

**BE IT ORDAINED**, by the Municipal Council of the City of Bayonne, as follows:

**Section 1.** That the Revised General Ordinances of the City of Bayonne Chapter 7, Traffic, Section 7-37.3, Handicapped Parking on Street for Private Residences, be and is hereby amended and supplemented as follows:

**RESTRICTIVE PARKING ZONES**

**DELETE**

**059. Justyna Petrinczyk, 346 Avenue C**

Beginning at a point on the east side of Avenue C, 85 feet south of the southeast corner of Avenue C and West 15<sup>th</sup> Street, and extending to a point 22 feet south thereof.

**072. William Rocheny, 23 New Street**

Beginning at a point on the north side of New Street, 65 feet west of the northwest corner of Avenue F and New Street, and extending to a point 22 feet west thereof.

**255. Maureen Anderson, 17 West 31<sup>st</sup> Street**

Beginning at a point on the north side of West 31<sup>st</sup> Street, 234 feet west of the northwest corner of West 31<sup>st</sup> Street and Broadway, and extending to a point 18 feet west thereof.

**281. Yolanda Ramos, 15 East 39<sup>th</sup> Street**

Beginning at a point on the north side of East 39<sup>th</sup> Street, 224 feet east of the northeast corner of East 39<sup>th</sup> Street and Broadway, and extending to a point 18 feet east thereof.

**299. Vito Barbitto, 55 East 4<sup>th</sup> Street**

Beginning at a point on the north side of East 4<sup>th</sup> Street, 119 feet east of the northeast corner of Lexington Avenue and East 4<sup>th</sup> Street, and extending to a point 21 feet east thereof.

**397. German Valdez, 160 West 49<sup>th</sup> Street**

Beginning at a point on the south side of West 49<sup>th</sup> Street, 155 feet east of the southeast corner of West 49<sup>th</sup> Street and Kenendy Boulevard, and extending to a point 17 feet east thereof.

**405. Margaret Oberanowicz, 80 West 42<sup>nd</sup> Street**

Beginning at a point on the south side of West 42<sup>nd</sup> Street, 311 feet west of the southwest corner of West 42<sup>nd</sup> Street and Avenue C, and extending to a point 18 feet west thereof.

**171. Valeriy D. Levin, 20 West 18<sup>th</sup> Street**

Beginning at a point on the south side of West 18<sup>th</sup> Street, 236 feet west of the southwest corner of Broadway and West 18<sup>th</sup> Street, and extending to a point 17 feet west thereof.

**174. George Baran, 15 West 18<sup>th</sup> Street**

Beginning at a point on the north side of West 18<sup>th</sup> Street, 225 feet west of the northwest corner of Broadway and West 18<sup>th</sup> Street, and extending to a point 18 feet west thereof.

**181. Carmine Fiorino, 120 West 50<sup>th</sup> Street**

Beginning at a point on the south side of West 50<sup>th</sup> Street, 115 feet west of the southwest corner of Avenue B and West 50<sup>th</sup> Street, and extending to a point 16 feet west thereof.

**RELOCATE**

**367. Kamal Morgan, 21 East 16<sup>th</sup> Street**

OLD LOCATION: Beginning at a point on the north side of East 16<sup>th</sup> Street, 10 feet east of the northeast corner of Court Place and East 16<sup>th</sup> Street, and extending to a point 17 feet east thereof.

NEW LOCATION: Beginning at a point on the north side of East 16<sup>th</sup> Street, 25 feet east of the northeast corner of Court Place and East 16<sup>th</sup> Street, and extending to a point 17 feet east thereof.
